Registration opens on February 19. Speakers announced to date include:

Ann Ravel, head of the California Fair Political Practices Commission; Kim Klein, of Klein and Roth Fundraising on fundraising in tough times; and Chris Hoene, Executive Director of the California Budget Project, a nonpartisan public policy research group.

Many efforts are underway as the Cupertino-Sunnyvale League participates in the details of planning the state convention. As a reminder, Elaine Manley and Susan Hough represent our League on the local Steering Committee composed of participants from all the other Santa Clara County Leagues. Read further and help us make this conference the best ever.

INITIATIVE AND REFERENDUM CONSENSUS MEETING

On Saturday Feb 9, fifteen members of the LWV-CS gathered to find a consensus on initiative and referendum reform. We heard from the group that's been studying the issues and then had a lively discussion.

In general, the group agreed that it's valuable to have the ability for people to bring ballot measures to the voters, but noted there have been unintended consequences. We agreed with the current LWV position that pre-review of proposed laws would often improve them and should be mandatory. We also suggested that the legislature be allowed to amend initiatives in the spirit of the original measure. This would allow for simple fixes without going back to the voters every time.

We emphasized the absolute need for transparency, integrity and impartiality in the entire process of drafting initiatives and referenda, circulating them, and bringing them a vote. Other goals are also desirable, but these three seemed to us the most important in order to preserve the best of the initiative and referendum process.

At this point, we send the results of our deliberations to the League of Women Voters of California. Their job is to sit down with the results of all the local league consensus meetings and condense them into a statewide consensus. It's a big job, but it's that kind of process that keeps the League of Women Voters a true grass-roots organization. Thank you to all participants for bringing your voice and your commitment to democracy in action!

NOTICE OF PREPARATION OF ENVIRONMENTAL IMPACT REPORT/ENVIRONMENTAL ASSESSMENT

VTA will be preparing environmental studies for the El Camino Real Bus Rapid Transit Project. What is Bus Rapid Transit (BRT)? BRT consists of a number of enhancements to make bus service along El Camino Real faster, more reliable, more frequent, and to enhance pedestrian facilities in portions of the corridor. VTA is proposing to provide BRT improvements along 17.4 miles of El Camino Real between the HP Pavilion and Palo Alto Transit Center in the cities of San Jose, Santa Clara, Sunnyvale, Mountain View, Los Altos, and Palo Alto.

The El Camino Real BRT Project will consist of the following enhancements:

- Convert two general purpose lanes to bus-only lanes in a portion of the corridor.
- Reduce wait times for buses at traffic signals.
- Operate every 10 minutes during weekdays.
- Replace major bus stops with new stations featuring real-time information, ticket vending machines, and enhanced lighting.
- Add bike lanes, widen sidewalks, augment landscaping, and improve street lighting along portions of the corridor.

VTA is holding four environmental scoping meetings to listen to concerns. What are the biggest environmental impacts of this project? What can VTA do to avoid, minimize, or mitigate these impacts?

LEAGUE NEWS

National – The League and other reform groups sent a letter to the Office of Congressional Ethics (OCE) urging them to stand fast on the OCE’s current rules of procedure. The OCE received suggestions from private attorneys who represent clients before the OCE. The letter calls the proposed changes “inappropriate for OCE as currently structured and would impede the agency’s ability to make the ethics process more accountable and transparent.”

State - State League announced that in the new legislative session in Sacramento the League will be fully engaged in efforts to strengthen California’s campaign disclosure requirements, will continue to work on reforms to the state budget process as well as working to make voting more accessible to all potential voters. Other issues garnering attention include: changes to the California Environmental Quality Act (CEQA), a water bond, fracking, changes to education funding (Weighted Student Formula), and early childhood education.
