DRAFT PLAN BAY AREA AVAILABLE FOR PUBLIC COMMENT TROUGH MAY 16

March 22 marked the release of the draft of the Plan Bay Area, the 25-year plan for integrated land use and transportation across the nine-county region. The draft is available for download at www.OneBayArea.org.

The public has until May 16 to comment on the draft, either by email (Info@OneBayArea.org), web (www.OneBayArea.org), regular mail (101 8th Street, Oakland, CA 94607), or at public meetings throughout the region:

Each meeting will consist of an open house from 6 to 7:30 PM to be followed by public hearings through 9 PM.

The draft of the plan's environmental impact report was released on March 29; it has the same May 16 deadline for comment as the plan.

BOARD GIVES GREEN LIGHT TO SMART VOTER® NEXT GENERATION TRANSITION

2nd Vice President Kathy Armstrong led a presentation and board discussion about plans to fully transition Smart Voter® and other LWVCEF voter service activities to the so-called "Next Generation" approach to online voter information. This new approach focuses on:

- Deciding what is the most important information to offer and how best to deliver it based on a clear understanding of the needs of voters;
- Building collaborations with other civic and media organizations to increase the League's overall public impact by leveraging the strengths and resources of each partner;
- Employing flexible, easy-to-use 21st century technologies for constant innovation in engaging ways to present content and support rapidly-changing mobile/social platforms.

The board was briefed on planned organizational and technology changes that are to take place over the course of this year. These include a gradual shift of all LWVCEF online information to the Next Generation approach and a closer integration with Smart Voter®, changes in staffing to include a senior editorial function, and a reconstituted oversight structure for Smart Voter®. The extent and specific timing of the changes will be dependent on achieving various milestones along the way.

VOTER SUPPRESSION BILLS IN NC: WHAT'S HAPPENING, AND WHAT IT MEANS FOR OUR COUNTRY

Early this month, multiple voter suppression bills – constituting one of the broadest attacks on voting rights we've seen this year – were introduced by members of the North Carolina Legislature, including proposals to require voter photo IDs, eliminate Sunday voting and reduce the same-day registration and early-voting periods. LWV North Carolina has been working hard to challenge the bills. But unfortunately, the problem goes deeper than just North Carolina, as similar bills are popping up in many state legislatures across the country. As we await the Supreme Court's decisions regarding challenges to the Voting Rights Act and the National Voter Registration Act, the actions in North Carolina serve as a powerful reminder that we must continually fight to protect the right to vote.

LEAGUE OF WOMEN VOTERS INTERVIEW WITH ASSEMBLYMEMBER PAUL FONG, 28TH ASSEMBLY DISTRICT

Editor: At the beginning of new legislative sessions, local Leagues interview their state representatives about issues of interest to the League. Here is the interview with Paul Fong. Others will appear in future VOTERS.

Q 1. California has both an ongoing structural imbalance, with insufficient revenue for the programs we would like to support, and an ongoing problem with the actual process of passing a budget. Even though we just passed Proposition 30, we recognize that this is just a first step towards financial stability for California.

a. What measures would you support to continue the progress that Proposition 30 represents?

b. What measures would you support to change the budget process?

Assemblyman Fong said California has both an ongoing structural imbalance, with insufficient revenue for the programs he would like to support, and an ongoing problem with the actual process of passing a budget. Even though we just passed Proposition 30, we recognize that this is just a first step towards financial stability for California.

Assemblyman Fong stated the Legislature will be reviewing various tax proposals this year. He supported Proposition 30 and also supports an oil severance tax to support Higher Education. He wants to include the state park system in funding. Also this year, a measure to tax sugar sweetened beverages a penny, at most at the retail level, has been introduced.

He also supports a split roll tax to update commercial rolls. The big corporations are getting 1978 tax rates. This needs to be updated.

He also supported middle class scholarships. The bill was defeated in the Senate but did get through the Assembly. The bill dealt with the tuition situation. Assemblymember Fong said that he will support something like that again.

Currently, there are proposals under consideration that the budget must be in the hands of the legislature 72 hours before approval. He feels three days is too long and one day to review and vote on the budget is sufficient amount of time. Assemblymember Fong feels the legislature has heard the budget multiple times and is tracking all amendments through various committees including the Joint Committee on Budget. The public elected the legislature to represent their interests. He supports a two-year budget process if there is the ability to amend the second year budget.

Q 2. There was an unprecedented amount of money spent in this election in California. What measures would you support to address the problem of money in politics? What improvements are needed to disclosure rules in California?

Assemblyman Fong introduced AB400. It would require listing on the petition for that measure the five top contributors to the ballot measure. He supports transparency in the initiative process all the way to end. He is the principal co-author of the Disclose Act.

His assistant mentioned the Fair Political Practices Commission and AB552. This bill will expedite the process for the commission to collect unpaid fines.

Q 3. California Environmental Quality Act (CEQA): During the last legislative session, efforts were made to change the California Environmental Quality Act. In particular, an end-of-session attempt at a significant rewrite of CEQA was attempted but was not successful. What is your view of CEQA? What changes do you think it needs, if any?

Assemblyman Fong supports CEQA laws but he feels they should be amended. He wants to keep the intent of CEQA to protect our environment because CEQA is a good law.

He mentioned he supported AB900. For any projects over \$100 million, the period of time to file a lawsuit is reduced to six months. He also wants to lower the threshold from \$100 million to \$5 - \$10 million to be included in the shorter time period to file a lawsuit.

Q 4. Local League Questions about issues of particular local concern.

The League brought up the issue of the San Jose Water District's proposal to increase fees by over 40 percent. Assemblyman Fong mentioned the California Public Utilities (CPUC) Rate Payers Advocate's counterproposal to increase fees of less than ten percent per year over several years. Assemblyman Fong's office has been in contact with the San Jose Water District and CPUC.

He also touched on hazardous waste, proper pill disposal, and fracking in California. He agrees with the environmentalists that fracking is dangerous to the environment.

Q 5. What other major issues do you think the Legislature must deal with in 2013? What are your personal priorities?

Assemblyman Fong stated initiative reform is a high priority along with Campaign finance reform. He supports full disclosure of any moneys coming in.

Assemblyman Fong feels the initiative process is being abused. It only costs \$200 to file an initiative proposal and he feels the cost should be higher, such as \$2,000 or \$2,500 to try to discourage the abuse.

He supports public financing to level the playing field.

LEAGUE NEWS

National – The League sent a letter to the U.S. Senate on April 18, 2013 regarding immigration reform and citizenship in a Democracy. The League is urging Senators to ensure that a path to citizenship is available to all who remain legally in the United States. Members of the Grassroots Lobby Corps will also be holding meetings with Senators on this issue.
